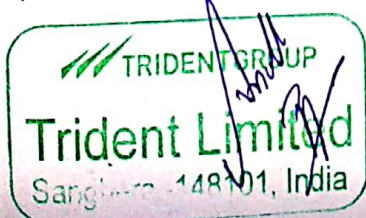

NOW, THEREFORE, it is hereby agreed by and between the Parties hereto as under:

1. That 'SLBSAMC' is an educational institution which is desirous of starting a degree course i.e. B.Voc (Software Development and Fashion Technology) with an intake of 100 students among other courses.
2. That Trident is the flagship Company of the Trident Group, having interest in Home Textiles & Paper and is one of India's leading textile houses of the Country.
3. That both the parties agree that the objective of the understanding shall be as under:
  - ✓ To generate ideas of mutual interest for the benefit and the up gradation of 'SLBSAMC';
  - ✓ To provide guidance and advise in respect to the development of the infrastructure of the College;
  - ✓ To provide in house practical training to the students of the B.Voc (Software Development) students from time to time, subject to availability of vacancy;
  - ✓ To provide in house practical training to the students of the B.Voc ( Fashion Technology) students from time to time, subject to availability of vacancy;
  - ✓ Placements of the students who have undergone the degree course in Software Development and Fashion Technology subject to their fulfilling the recruitment criteria and procedures of Trident
4. That the role of Trident shall mainly be advisory in nature and shall provide guidance and expert advice to 'SLBSAMC' from time to time for the up gradation of the educational institution.
5. That SLBSAMC shall not hold Trident responsible for any loss or mis-happening and shall not claim any losses, damages etc. from Trident. All rules, regulations, policies as applicable to the employees of Trident shall be applicable to all such trainees during Training period. These trainees shall not and would not ask any preferential treatment with regard to any of the issue / matter related to the terms and conditions of the training or employment.
6. SLBSAMC shall at all times maintain and keep secret and confidential any knowhow, figures, information, trade secrets, data or confidential documents in written/verbal form, obtained during the course of training which he/she has or may acquire from time to time relating to business of the Company, to any person(s)/ authority/ organization /statutory body without written permission of Trident. The Trainee shall take such steps and precautions as may be necessary to preserve and protect any proprietary information from publication, reproduction, communication or other unauthorized disclosure to the third parties. The terms of this clause shall survive termination of this Agreement.
7. That SLBSAMC shall not quote Trident's name or reproduce its logo in any form or medium without Trident's prior written consent.
8. The Memorandum of Understanding shall be valid upto 30.06.2020 and shall be extended with mutual consent of both the parties unless terminated earlier.
9. That the MOU can be terminated by either party after giving 30 days notice in writing to the other party for whatsoever reasons. However, this should not affect the academic session in progress.
10. That amendment to this Memorandum may be made in writing at any time by agreement between the parties. In addition, this MOU will be reviewed at intervals agreed between the parties and be updated, as necessary, in the light of experience of its operation in practice.

The place of arbitration shall be at Sanghera, India. The language used in arbitral proceedings shall be English.

12. That this MOU and all subsequent agreements which shall be entered into between the Parties shall be governed by Indian law. The Courts at Barnala, India shall have the exclusive jurisdiction in all matters arising under this MOU.



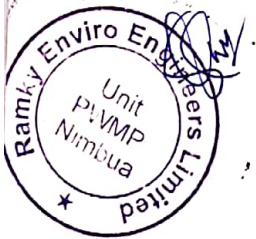

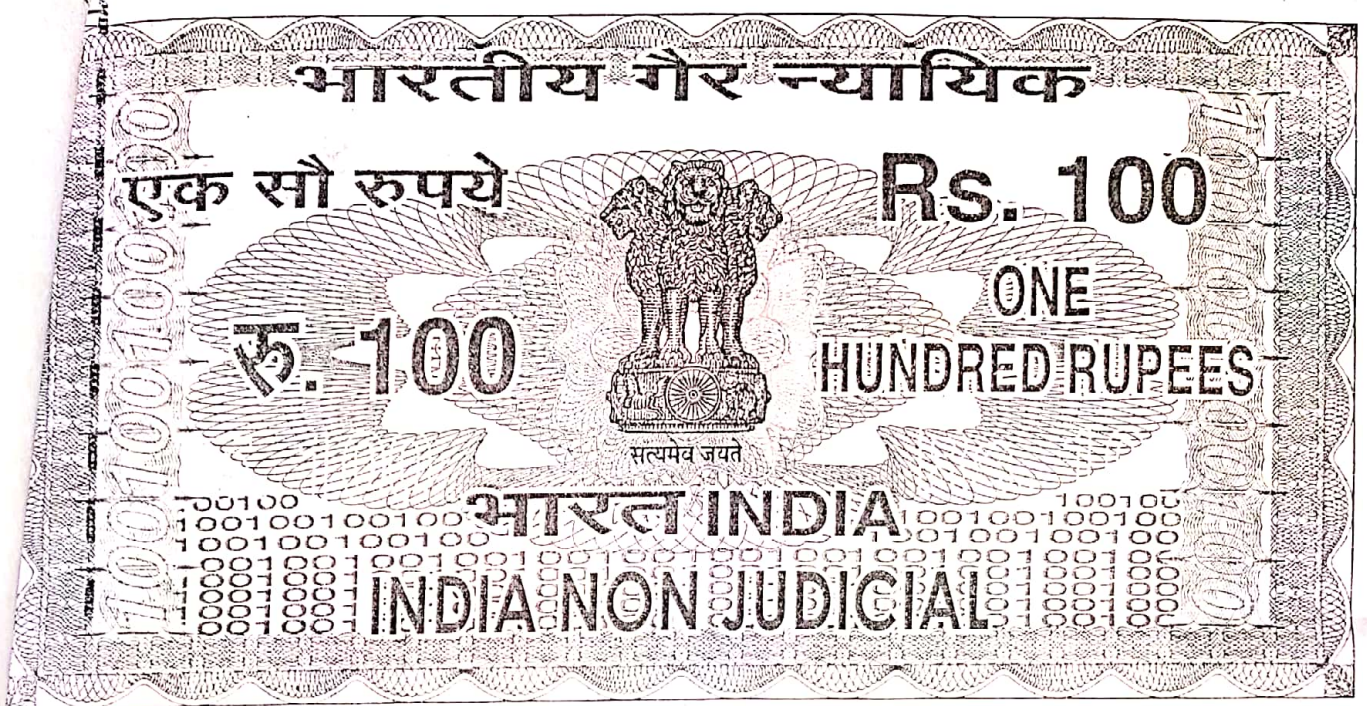

This Agreement for purchase & disposal of E-Waste (Agreement) is entered into on this 10 day of August of the year Two thousand and 21 by and amongst-

**RAMKY ENVIRO ENGINEERS LIMITED (CIN- U74140TG1994PLC018833)** having its Registered office at Ramky Grandiose - Floor 13, Ramky Towers Complex, Gachibowli, Hyderabad - 500032 and Project Office at Village Nimbua, Teh- Derabassi, Distt. Mohali, Punjab, (herein after referred as "Ramky" which expression shall unless contrary to the context or meaning thereof, mean and include its successors and permitted assigns) represented by Sh. Sandeep Himalayan duly authorized vide Board of Directors Resolution dated 03 September, 2014.

AND

**SHRI LAL BHADUR SHASTRI ARYA MAHILA COLLEGE, BARNALA**, having its Registered Office/ Principal Office at **RAM BAGH ROAD, BARNALA**, (herein after referred to as the "the Generator", which expression shall unless repugnant to the context or meaning thereof, mean and include its successors and permitted assigns) represented by **DR. (MRS.) NEELAM SHARMA, PRINCIPAL** of the college.

WHEREAS;

- A. Ramky is operating a facility for the collection, transportation, dismantling, refurbishing and disposal of e-waste at Village Nimbua, Teh- Derabassi, Distt. Mohali, Punjab authorised by Punjab Pollution Control Board.

B. The Generator in compliance of the E-Waste Management & Handling Rules, 2016, desires to avail the services of Ramky for disposal of their segregated E-Waste, more fully detailed hereinafter under this Agreement.

C. The Generator has approached Ramky and desires to appoint Ramky for the purpose of collection and disposal of its segregated E-Waste and the same has been accepted by Ramky in accordance with the terms of this Agreement.

**NOW THIS AGREEMENT** witnesses as follows;

**I. DEFINITIONS AND INTERPRETATION**

1. Electronic Waste (E-Waste) - The term E-Waste will refer to the below mentioned electrical and electronic waste for the purpose of this Agreement which includes;

- a) Computers & Peripherals (CPU, Keyboard, Mouse & Monitor)
- b) Laptops
- c) Servers
- d) PCBs
- e) Mobiles or Communication devices
- f) Mother Boards (Computers & Laptops)
- g) Security Devices
- h) Telecom Equipment
- i) Printers & Scanners
- j) Military Electronic
- k) Control Systems
- l) Data cables & wires
- m) UPS & Batteries
- n) Consumer Electrical & Electronics (White Goods)
- o) CD/DVD Machine
- p) Fluorescent containing lamp (Tube Lights, CFL any other lights), Cartridges.

2. In this Agreement, unless the subject or context otherwise requires:

- a. Reference to the singular number shall include references to the plural number and vice-versa;

- b. References to a "person" shall include references to natural persons, partnership firms, companies, bodies corporate and associations, whether incorporated or not or any other organization or entity including any governmental or political subdivision, ministry, department or agency thereof;
  - c. References to recitals, clauses and schedules are to recitals, clauses and schedules to this Agreement;
  - d. Any reference herein to a statutory provision shall include such provision, as is in force for the time being and as from time to time, amended or re-enacted in so far as such amendment or re-enactment is capable of applying to any transactions covered by this Agreement.
  - e. Clause headings used herein are only for ease of reference and shall not affect the interpretation of this Agreement.
3. The Schedules & Annexure shall form an integral part of this Agreement.
  4. All capitalized terms used in this agreement shall have the meaning specifically defined in this Agreement shall, unless inconsistent with the context under this Agreement.

## II. SCOPE OF THE AGREEMENT

1. Ramky shall collect, transport, and dispose the E-Waste collected from the premises of the Generator. It shall be the responsibility of Ramky to demagnetize the hard disks before disposing them off in accordance with the terms of the contract. If the hard disks come along with the CPU the activity would be taken care by Ramky at free of cost. However, in case of an exclusive consignment of hard disks for demagnetization by the Generator. It shall be chargeable in accordance with the terms of the contract.
2. The Generator shall segregate the E-Waste at one designated place within the premises from where the representatives of Ramky shall collect the E-Waste. All the segregated E-Waste shall be stored in the appropriate bins and/or container as prescribed under the applicable law and Ramky shall not be liable for any damage caused due to inappropriate storage of E-Waste at the premises by the Generator.
3. Upon intimation from the Generator, Ramky shall within 15 days there from, arrange for collection of E-Waste as per the applicable provisions. The Generator shall issue delivery challan before collection of the E-Waste from the designated place by Ramky.
4. The E-Waste collected shall be weighed by the Parties at the nearest weighment center available as identified by the Parties. The weighment of the E-Waste shall be done in the presence of the representatives of both the Parties and both the Parties shall acknowledge such weighment slip generated. In case of any discrepancy in the weighment as per delivery challan and the weighment slip, the details as per weighment slip shall be considered for payment by Ramky.

5. The Generator liability shall cease once the E-Waste has been collected by Ramky from its premises except for any non-disclosure of any material information known to the Generator with regard to E-Waste from Ramky during the handover of such E-Waste. It is specifically agreed and understood that compliances of applicable law during transportation and disposal of E-Waste shall be exclusive responsibility of the Ramky.
6. Ramky shall, issue a safe destruction certificate as prescribed under applicable laws within fifteen (15) days from receipt of such request.

### III. PAYMENTS

1. Ramky shall pay to generator an amount of Rs. (as per agreed T&C of quotation) per each Kgs/Nos. for payment of E-Waste collected shall be as per the weighment slip, Invoice submitted and accepted by Ramky.
2. Generator shall pay to Ramky an amount of Rs. (as per agreed T& C of quotation) per Kgs for the payment of service charges for collection & disposal of fluorescent containing lamps as Tube lights, CFL, Cartridges and any other Lamps shall be as per the weighment slip, Invoice submitted and accepted by Ramky.
3. The payment shall be made by either party within thirty (30) days of the collection of material in the form of an electronic transfer. Ramky may withhold any payment in case of any dispute regarding the weighment of E-Waste and any such withholding of payment shall under this clause shall not be considered as a material breach of this Agreement.

### IV. TERM AND TERMINATION

1. This Agreement shall be in force for a period of 3 years from the date of signing of this Agreement. Upon completion of the term, the Agreement may be renewed at the option of both the Parties in writing on mutually agreed terms and conditions.
2. The Agreement may be terminated by either party without assigning any reason, by giving fifteen (15) days prior written notice to the other Party.

### V. COMPLIANCE WITH LAWS

1. Ramky represents and warrants to the Generator that it has all necessary statutory permissions, consents, approvals and licenses to carry out business of collection, transportation, storage, management and disposal of E-Waste and it shall maintain all such permissions, consents, approvals and licenses during the term of this Agreement.
2. Ramky further agrees that:
  - i. It shall exercise all safety precaution and best management practices, required by law, in providing service under this Agreement;
  - ii. It shall notify the Generator immediately if any permit, licenses, certificate, consent approval or identification number required for the performance of its service under this Agreement has been revoked, modified, expired, suspended or not been renewed;

## X. MISCELLANEOUS

1. Force Majeure: Neither party shall be liable for any delay or failure to perform its obligations here under, if such delay or failure is due to reasons beyond the control of the concerned party due to any Force Majeure event which shall include but not limited to, strikes, riots, wars, fires, epidemics, quarantine restrictions, unusually severe weather, earth quakes, explosions, acts of God or state or any public enemy or acts mandated by applicable laws, regulation or order of any Governmental body.

The Party affected by such Force Majeure event shall immediately notify the other Party who shall have the right to terminate the Agreement with immediate effect upon giving a written notice if such Force Majeure event continues for more than sixty (60) days.

2. Confidentiality: The existence and all terms and conditions of this Agreement are confidential to the Parties, and shall not be disclosed to any third party without the other party's prior written consent, save and except to their respective officers, employees or as required by law on a need to know basis. The confidentiality obligation under this Agreement shall exist during the term of this Agreement and for a period of three (3) years from the expiry of this Agreement.
3. Notice: Any notice or other communication under or in connection with this agreement shall be in writing in the English language and shall be delivered personally or delivered to the party due to receive the notice or communication at its address set out below or such other address as either party may specify by notice in writing to other from time to time.
4. Amendment & Modification: Amendments and modifications to this Agreement shall be valid only if made in writing and signed by the Parties.
5. No Representation: Nothing in this Agreement shall authorize any Party to engage in transactions in the name of the other Party or in any activities, which may create a liability on such other Party.
6. No Assignment: Parties shall not assign or transfer this Agreement or any Order or any parts of its rights and obligations hereunder to any person or corporation without the prior written consent of the other Party.
7. No Waiver: No failure to exercise, nor any delay in exercising, on the part of either Party, any right or remedy hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right or remedy prevent any further or other exercise thereof or the exercise of any other right or remedy.
8. Headings: The headings of the Clauses of this Agreement are for convenience only and shall have no effect in the interpretation of this Agreement.
9. Entire Agreement: This Agreement and the Order(s) constitute the entire agreement between the Parties.
10. Duplicate Agreements: This Agreement has been signed in two counterparts, each of which shall be deemed as an original but both of which together shall constitute one and the same instrument.

CLAUSE 5

GENERAL POLICIES

- Only books and other items available on the premises of each library may be used for ILL transactions.
- The decision to lend material is always at the discretion of the lending library.
- Each participating library should have an ILL policy that stipulates which materials are not available for lending, loan periods, renewal periods and policy, recalls, lost or damaged materials.
- Each participating library should keep the records of the number of requests sent and received and the number satisfied in each case using their own methods and software.
- Official request should go through the online form or through e-mail.
- Libraries receiving requests should deal with them as quickly as possible. When a request cannot be satisfied, then the borrowing library should be notified immediately.
- Loan periods should be adequate to allow for transmission in both directions as well as use by the borrower.

CLAUSE 6

- If damage or loss occurs, the borrowing library must meet all the costs of repair or replacement.
- Borrowing libraries must comply with the conditions established by the lending library.
- Ensure that staff is familiar with Inter Library Loan policies and procedures.
- Keep statistics on the number of items requested and the number received.
